❖ Objectives:

- i. Organizing social activities.
- ii. Conducting seminars, workshops and other types of academic discussion.
- iii. Exchange of faculty to the mutual benefit of the Institutions.
- iv. Exchange of academic materials e.g. e-books and e-journals, psychological tests and other relevant items.
- v. Collaboration in teaching, research and development in the field of Teacher Education.

Both the colleges under this MoU agree to provide their academic and technical assistance to carry out activities which will foster institutional growth through collaboration and exchange of resources.

❖ General Terms of MoU:

- a. **Duration of MoU:** This MoU will be effective from the date of the agreement and will have an initial duration of two years. There is also a provision to extend the MoU in case all the parties agree to the same.
- b. **Co-ordination:** In order to carry out and fulfill the aims of this agreement, each college will empower an appropriate faculty to co-ordinate the implementation of activities. The concerned faculties will meet regularly to discuss the plan, implementation and progress of the activity.
- c. **Technical and Financial Support:** Technical & Financial support for each activity will be shared by the respective college.
- d. **Confidentiality:** At any time, after executing the activities of this MoU each college agrees that none of the college will disclose any information relating to these activities without the consent of any of the college which are under this MoU.
- e. **Termination of MoU:** The partnership covered by this MoU will be terminated upon the completion of the agreed for a period of two years. The agreement may also be terminated with a written one month notice from both the sides.
- f. **Extension of Agreement:** The MoU may be extended according to the willingness of the colleges with prior intimation and permission of the authorities one month before the end of the existing MoU.

- g. **Communication:** All notices, documents and any other communication under this agreement in connection herewith will be in written form and sent to the postal address or email of the concerned college. Any notice will be effective from the date on which it is signed.
- h. **Addendum:** Any addendum to this MoU will be in written form and signed by authorities of agreed colleges.
- i. **Venue of the Programme:** Each college will organize any programme on their own premises in collaboration with other college by using their own assistance and resource.

❖ Other Provisions:

- Initially this type of exchange may be implemented in the field of sports activities and cultural programme.
- Students, teachers, resource persons and participants may use the resources of colleges under MoU during the exchange and extension activities also.
- Teaching may be shared with the students due to prior permission of the authorities with a proper Identity Card.
- Students and Teachers may visit and use the college library as well.
- Both the parties assume that that this agreement does not go against the rules and regulations of the Government of West Bengal, University Grants Commission, NCTE and Affiliating University.
- Faculty exchange for special lecture, seminar class and other programme will be made with the consultation of specific faculty as and when needed.

❖ Declaration:

The provisions mentioned in the above MoU is thoroughly discussed and reached at the consensus that both the institutions will follow the provisions and implement the same.
